Provision of requested information

Thank you for your request for information about storm overflows at Stowe Hill and improvements project for the River Nene, which we received on 01 April 2025. Your request has been considered under the Environmental Information Regulations 2004.

Nether Heyford is served by Bugbrooke WRC. We are pleased to report that this WRC spilled only 4 times in 2024, far below the 2050 spill target of 10 times per year. We also have another site, Weedon WRC which is upstream of Nether Heyford. This site spilled 65 times in 2024 so would be considered a high spiller. We regularly investigate our high spilling overflows and complete maintenance where any asset defects are identified. When hydraulic capacity is the cause of spills (due to climate change and storm conditions) we must reduce spills to an average of 10 spills per year by 2050. Weedon WRC is included in our investment programme for additional monitoring to ensure all flow settings at the inlet to the WRC are correct and this will be completed before December 2026. If any defect were to be identified this would then also be rectified. If hydraulic capacity is confirmed to be the cause of spills (due to climate change and storm conditions) we would then have a requirement to reduce spills to 10 spills per year by 2050. We will begin planning our investment cycle for 2030-2035 in 2026 and it is very helpful for us to know that this is a particular overflow of concern as we can use this information to help us to prioritise future investments.

Our investment plan for the period 2025-2030 recognised the importance of the River Nene from an environmental and societal perspective. We are very pleased to be able to confirm that we are investing to improve 22 overflows that discharge to this water course (including the new and old course of the Nene) (details provided below) in the period 2025-2030. Whilst we are sorry that Weedon WRC itself is not included for spill improvement in the current investment cycle, we hope you will agree that the River Nene will be a significant beneficiary of spill improvement schemes.
