Please find attached Start Stop Time 2020.xlsx showing the start stop data available for 2020. This data is from a recent S108 submission made to the EA and is considered the most reliable historical data we hold, and BUCKST FELTST FOXTST GEATST FFT Data.xlsx showing the data we hold for part b.

Start stop times for 2021 to 2024 can be found on our website <u>Storm overflows</u> and the most recent monthly data for 2025 can also be found on our website <u>Monthly EDM Publication</u>. The monthly data is a summary of all EDM activations as shown on the storm overflow map. It is not quality assured to a regulatory return standard, so it has a lower data quality and should be considered indicative of an activation, rather than confirmation of a spill.
