### **Provision of requested information**

Thank you for your request for data relating to water abstraction and charges for industrial and commercial users, which we received on 7 May 2025. Your request has been considered under the Environmental Information Regulations 2004.

Anglian Water charge on a cost reflective basis according to volume and peak demand, therefore, price does not vary according to commercial activity.

We cannot provide the data in the exact format that you have specified categorised by business type. However, we have provided an attached excel data file that details volumes of water, revenue (£), and quantity of Non Household Premises within each charging band for the periods that you have requested.

#### For Abstraction

SW = surface water abstraction, generally for public water supply.

SW transfer between sources = a surface water abstraction that is then discharged into another waterbody.

Typically these are the river abstractions we use to top up reservoirs, from where the water is subsequently reabstracted as "SW".

GW = groundwater abstraction, generally for public water supply.

GW transfer between sources = a groundwater abstraction that is discharged into another waterbody.

Typically these are river support boreholes used for environmental support at times of low river flow.

Hartlepool GW = The total abstraction for Hartlepool Water Co. All their sources are groundwater.

TW = Tidal abstraction.

The figures are given as megalitres and the period is fiscal years, as this is the abstraction year defined in our licences.
